## **Massachusetts Historical Commission Visits UUCW for Set in Stone Grant**

On July 17 UUCW hosted a site visit from Tracey Fortier, Preservation Planner, from the Massachusetts Historical Commission (MHC), and John Wathne, Principal Engineer, from Structures North Engineering. Their visit signaled the official start of Phase 2 Set in Stone masonry repairs.



The pair undertook a thorough review of the building, taking many measurements and pictures. They confirmed the scope of Phase 2, which will finish up mortar work on the East elevation building face and repair the East face of the bell tower. We hope to “fast-track” this work, sending out requests for bids in late August and starting work this fall.

## **Bye-Bye Boiler... Thank You Donors!**

All is quiet in the boiler room as our rusty old relic is laid to rest. Over the next few weeks, Chair City Oil (CCO) will dismantle and haul out the old boiler, and assemble a new commercial grade boiler in its place. Peter and Dave Tourigny of CCO worked closely with us to optimize purchase and installation costs, which were finalized at \$15,000.

Some key donations helped push us over the finish line for funding. UUCW received a \$2500 grant from the Agnew M. Lindsay Trust. Based in Bedford, New Hampshire, this Trust supports 501(c)3 organizations that perform community service work, including service for the food insecure and rural communities. We also received generous donations from individual supporters, including Gordon Harper of Keene, NH. We are deeply grateful for this financial support and acknowledgement of the community work we are doing.

## **Our Neighbor's Kitchen Receives 2<sup>nd</sup> COVID-19 Grant**

Hungry diners are driving through our circle in hefty numbers as word of Our Neighbor's Kitchen take-out dinners spread. On July 9 the Sackett family served a chilled salad trio: grilled chicken Caesar salad, tuna macaroni salad and marinated veggie salad, with trail mix cookies. On July 23 the Faucher family served the "three C's": classic chili loaded with meat and beans, fresh coleslaw, and cornbread. Coming up on July 30, Joe & Jill return to serve cheesy beef bake, tomato & cucumber salad, and sweet shortbread.

Our Neighbor's Kitchen meals are free to all, and while donations are gladly received, they serve to cover only a fraction of the costs. We were thrilled to receive a grant from Church Mutual Insurance Company's foundation, CM CARES®, which has established a \$500,000 "COVID-19 Protecting the Greater Good Recovery Fund." This fund prioritized donations to support essential needs provided by 501(c)3 organizations that perform community service work that are experiencing increased demand caused by the pandemic.

The grant extends our ability to keep operating "in the black," and will go directly to expenses such as groceries, take-out containers, and utility costs such as propane.
