# 2021 UUA GA Goes Online for Second Consecutive Year

The 2021 General Assembly of the Unitarian Universalist Association ("GA") convened online as an all-virtual event from Wednesday, June 23 through Sunday, June 27. GA was also an all-virtual event in 2020, because of the COVID pandemic.

GA is held every year for five days in June, and incorporates the UUA annual business meeting, known as General Session, elections of officers Trustees as needed, several worship services, and many workshops and presentations. Congregations in good may send standing one or delegates to GA to represent their congregation and vote in General Assembly. This year, for the first time, UUCW qualified to send two delegates, so we had a vote in General Session. Our delegates were myself and our Governing Board Chair, Jill Sackett.

Typically, GA meets in person with some 2,000 attendees. Attending is costly, with registration running around \$200 per person, in addition to travel expenses, food, and lodging for at least four nights. Consequently, fewer than 5 percent of active UUs have ever

attended a GA, and many congregations have never sent a delegate. Several years ago, GA began allowing delegates to attend General Session and vote remotely, in an effort to increase equity and access. But the other elements of GA, such as the scores of workshops, the smaller worship services, the huge Exhibit Hall with over a hundred booths, social meetups and gatherings, and the overall experience, required inperson attendance.

In 2020, the UUA found that hundreds of people were able to attend GA for the very first time, paying the registration fee, because they could log in from home. GA online was an exciting experience, including social events, workshops, worship services, and General Session, all done largely through Zoom and a cell phone social similar media app to Facebook Messenger. Registration exceeded 4,000 paid attendees.

The 2021 GA benefited from far more planning time. The planning committee chose a different app called Whova which integrated more features and could be accessed on a phone or a computer. Most program items were still done via Zoom. Some 78 workshops were pre-recorded and made available in an "on-demand library" which could be watched before and after GA or at any time during the week. A full schedule of live panels and workshops was along with programmed, worship services, affinity group meetups, social

events and of course, four days of General Session. A virtual Exhibit Hall included UU organizations, vendors and individuals. Attendance was similar to the 2020 GA, around 4,000.

No officers were on the electoral slate this year. The only contested election had two candidates vying for an open seat on the Board of Trustees. Sam Trumbore (trumbore.org), a long-time experienced UU, was elected by a large majority, defeating challenger Jim Kiskel (fifthprincipleproject.org, coauthor of *Used to Be UU*). UUA Board of Trustees meetings are held via Zoom and are open to the public.

Several minor amendments to the UUA Bylaws were passed.

Delegates approved three Articles of Immediate Witness (AIW). These are statements affirming the need positive action on an issue or situation; they are not binding resolutions. I am a member of **TRUUsT** (Transgender Religious UU professionals working Together) and signed the AIW which TRUUsT sponsored: a call to "Defend Advocate and with Transgender, Nonbinary, and Intersex Communities." The two other AIWs approved are "Stop Voter Suppression and Partner for and Voting Rights a Multiracial Democracy" "The COVID-19 and Pandemic: Justice. Healing. Courage." which calls for an equitable, universal health care system and support of the PRO Act HR-842

General Session also approved the UUA Statement of Conscience (SOC), "Undoing Systemic White Supremacy: A Call to Prophetic Action," which may be read online here:

The prestigious Ware Lecture was given jointly by two speakers this year: Stacey Abrams, former minority leader in the Georgia House of Representatives and crusader for voting rights, and Desmond Meade, author of *Let My People Vote* and activist leader for voting rights in Florida.

Outside of organized programming, online live social meetups and an ever-proliferating number of forums were filled with vigorous debates and discussions. Topics such as inclusion, rights for disabled persons, anti-racism, Indigenous peoples' rights, the proposed 8th Principle, the ongoing discussion about updating Article II (the overall purpose of the UUA), and criticisms of current trends in UUism made for lively exchanges.

While most of GA's recorded programming is only accessible to registered attendees, some items, such as the Ware Lecture, may be available for general viewing in the future.

Although both all-virtual GAs had their rough spots and insufficiencies, their success in including persons who are unable to attend in-person GAs for any of a myriad reasons is compelling. The UUA is considering combining inperson GAs with all-virtual GAs in alternating years, and plans to make far more of the in-person GAs accessible remotely.

The 2022 GA is scheduled to be held in Portland, Oregon next June.

- 2. Justice, equity and compassion in human relations.
- 3. Acceptance of one another and encouragement to spiritual growth in our congregation.
- 4. A free and responsible search for truth and meaning.
- 5. The right of conscience and the use of the democratic process within our congregations and society at large.
- 6. The goal of world community with peace, liberty and justice for all.
- 7. Respect for the interdependent web of all existence for which we are a part.
